We are pleased to learn of your interest in graduate education at the International University of Japan (IUJ).

IUJ, in accordance with the international emphasis embodied in its founding principles, welcomes well-qualified students from a variety of backgrounds and from various parts of the world to join its graduate level programs taught in English.

As a graduate school chartered by the Japanese Ministry of Education, Culture, Sports, Science and Technology (MEXT), IUJ must operate within the governmental policies regulating educational institutions. Therefore, some of our application requirements and procedures differ from those in other countries. This guide contains information to enable all applicants to complete the application process smoothly. Some information may not be applicable to you, so please refer to the “notes” sections or ask the Admissions staff for clarification. Please prepare your application online, carefully following all the instructions provided in these guidelines.

This guide, along with the IUJ brochure and website, should answer most of your questions about the admissions process. Please do not hesitate to contact us if you need further assistance.

Master’s Programs Offered by IUJ

IUJ has 2 graduate schools:

- **Graduate School of International Relations (GSIR)** offers 5 master’s programs and 7 degrees:
 - International Relations Program - 2-year program (IRP: MA in International Relations or MA in Political Science)
 - International Development Program - 2-year program (IDP: MA in International Development or MA in Economics)
 - Public Management and Policy Analysis Program – 2-year program (PMPP: MA in Public Management or MA in Public Policy)
 - Japan-Global Development Program - 2-year program (JGDP: MA in International Relations, MA in International Development, MA in Economics, or MA in Public Management)
 - International Public Policy Program - 1 year program (IPPP: Master of International Public Policy)
- **Graduate School of International Management (GSIM)** offers 4 master’s programs and 2 degrees:
 - 2-year MBA Program (MBA – Master of Business Administration)
 - 1-year MBA Program (IMBA – Master of Business Administration)
 - Japan-Global Development Program – 2-year program (JGDP – Master of Business Administration)

Note: IUJ does not offer any undergraduate degrees.

Minimum Qualifications for Admission

The International University of Japan considers individuals with one of the following qualifications to be eligible applicants:

- A. Those who hold, or are expected to receive, their bachelor's degree from an accredited four-year college or university in a country where 16 years of formal schooling by August 31, 2026 is required.
- B. Those who hold, or are expected to receive, their bachelor's degree from an educational institution in a country where 15 years of formal schooling by August 31, 2026 is required may be regarded as eligible applicants based on their undergraduate performance.
- C. Those who hold a bachelor's degree in a country where 14 years of formal schooling by August 31, 2026 is required, have one year of research experience after completing their bachelor's degree at an academic institution, and are at least 22 years of age. *Note: An official letter attesting to the academic research experience is required as part of the application documents.*
- D. Those who hold a bachelor's degree in a country where 14 years of formal schooling is required or an associate's degree (one of the higher tertiary degrees issued usually after 14 years of schooling by such educational institutions as junior colleges in the U.S.A., Japan or other countries that have compatible education systems) by August 31, 2026, are at least 22 years of age, have 2 years of work experience, and have demonstrated academic ability recognized as equivalent to that of a bachelor's degree holder by IUJ prior to application. Those in this category should contact the IUJ Admissions team for details.

Special considerations

1-year MBA Program: In addition to holding a bachelor's degree, applicants for the 1-year MBA Program are expected to have strong work experience. While a minimum of 3 years of full-time work experience after having obtained a Bachelor's degree is **required**, five or more years is preferable.

1-year IPPP: In addition to holding a bachelor's degree, applicants should have 5 or more years of professional experience in the government or in public sector.

Admissions Policy

The fundamental objective of the Admissions Committee at IUJ is to admit to our graduate programs as many of the most competent students as possible, limited by the number of places available in each school (see below).

In order to select the most competent students, the committee will review all the applicants individually based on several criteria listed below, through interviews (when applicable) and/or documentary screening. IUJ does not use a predetermined formula for rating the content of undergraduate education, nor does it use quotas based on nationality, age, or gender.

The Graduate School of International Relations (GSIR) seeks individuals who have a long-term vision to see the trends of the times and a global perspective, so that they can recognize and respect diverse values, demonstrate advanced analytical and problem-solving skills in dealing with the wide-ranging issues facing the international community, and aim to become leaders who can put these skills into practice in the international arena.

〈Qualities and Abilities We Seek in Our Students〉

The master's programs in the GSIR seek students with the following skills and abilities:

1. Well-defined motivation to pursue graduate studies;
2. Scholastic achievements at the undergraduate level meeting the standards required for coursework and research activities at the GSIR;
3. Aptitude and potential to become leaders who can significantly contribute to and/or manage increasingly global organizations;
4. Maturity to meet the demands of a rigorous academic experience;
5. Fair sense of values that will enable them to join our multinational and multicultural IUJ community, interest in understanding different cultures, drive to actively communicate with others, and a desire to create a world-wide network of contacts; and
6. Proficiency in written and spoken English required for coursework and research activities at the GSIR.

(Selection Methods)

In order to maximize the diversity of its student body, the GSIR master's programs evaluate and select applicants from various backgrounds through document screening, the GSIR master's programs evaluate and select applicants from various perspectives through document screening (including a personal statement, research plan, English test score, academic transcripts, and proof of (expected) graduation) and interviews, without regard to the applicant's field of specialization in their undergraduate education, age, gender, nationality, etc.

【Graduate School of International Management】**(Desired Student Profile)**

Based on its basic philosophy of "fostering social responsibility and global business capabilities," the Graduate School of International Management (GSIM) seeks individuals who will acquire the ability to practice appropriate management based on solid theoretical and practical skills at the cutting edge of global business, and who aim to become leaders able to fulfill their duties with a constant awareness of international social responsibility.

(Qualities and Abilities We Seek in Our Students)

The master's programs in the GSIM seek students with the following skills and abilities:

1. Well-defined motivation to pursue graduate studies;
2. Scholastic achievements at the undergraduate level meeting the standards required for coursework and research activities at the GSIM;
3. Aptitude and potential to become leaders who can significantly contribute to and/or manage increasingly globalizing organizations;
4. Aspiration to acquire the management knowledge and problem-solving skills required of business leaders;
5. Maturity to meet the demands of a rigorous academic experience;
6. Fair sense of values that will enable them to join our multinational and multicultural IUJ community, interest in understanding different cultures, drive to actively communicate with others, and a desire to create a world-wide network of contacts;
7. Potential to understand global business and act with socially responsible conviction; and
8. Mathematical skills and proficiency in written and spoken English required for coursework and research activities at the GSIM.

(Selection Methods)

In order to accept a wide range of appropriate and capable students from diverse backgrounds, the GSIM evaluates and selects each applicant individually through document screening (including a personal statement, research plan, mathematics test score, English test score, academic transcripts, and proof of (expected) graduation) and interviews, without regard to the candidate's field of specialization in their undergraduate education, age, gender, nationality, etc.

Number of Students and Time of Enrollment**Type of Applicants**

IUJ receives applications from two groups:

Domestic Applicants (residents of Japan, regardless of nationality. "Resident" refers to Japanese passport holders who are living in Japan through the Admissions deadlines or those holding a non-Japanese passport but have a Residence Card or Special Permanent Resident Certificate), and

International Applicants (residents of countries other than Japan, regardless of nationality. This implies Japanese nationals with residential permission in a 2nd country and who are living in that country through the Application/Admissions process, or non-Japanese with no residential status in Japan through Application/Admissions). Admissions guidelines and fees are slightly different for domestic and international applicants.

Number of Students

The GSIR will admit up to 110 students for its 5 programs per year.

The GSIM will admit up to 75 students for its 4 programs per year.

Time of Enrollment

Fall Term (beginning at the start of September of each year) in principle

Decision Cycles and Admission Schedules**For Domestic Applicants:**

It is mandatory for residents of Japan to take an online exam (an interview for all applicants and a math test for GSIM applicants who do not have GMAT/GRE scores) conducted by IUJ faculty members in English. Each program offers several opportunities for admission interviews throughout the selection cycle. These online interviews are scheduled between January and June. IUJ bases decisions on each applicant's admission on the evaluation of the interview, test

results, and application materials submitted. Applicants will be notified of the results according to the “Admission Schedules” below.

Exam Site: Online

Applicants will be informed of details relevant to the entrance examination after the application deadline of the relevant admissions intake.

For International Applicants:

International applicants should submit all required documents online and pay the application fee by the stated deadline. Incomplete applications and applications received after the deadline will not be considered. Document screening will be conducted immediately following the application deadline(s). The decision on whether or not to admit a candidate will be based on the evaluation of all the required documents submitted and the entrance exam. Those GSIM applicants who choose to take an IUJ Math test need to be interviewed after the test. The Math test and Interview will be arranged individually after the application deadline(s).

Important Notes for International Applicants (Residents of countries other than Japan):

Full Scholarship Consideration Priority

1. If you would like to be considered for a full scholarship such as that offered by ADB, JERA, KMMF, Mitsubishi UFJ, etc., please apply in the 1st or 2nd intake to meet the deadlines of these outside scholarship foundations. Applicants in the 3rd intake are less likely to be considered for a full scholarship.
2. If you would like to be considered for a MEXT scholarship (University Recommendation), you are required to apply in the 1st intake. Exceptional candidates may be granted this scholarship at IUJ's recommendation.

IUJ Math test and Interview (GSIM IUJ Math Test Takers only)

IUJ Math tests and Interviews will be arranged individually for GSIM IUJ Math test takers after each application deadline.

Full Scholarship Consideration Priority

If you would like to be considered for a full scholarship, please apply in the 1st or 2nd intake. Applicants in the 3rd intake are less likely to be considered for a full scholarship.

IUJ Math test (Only for the GSIM applicants opting to take the IUJ Math Test)

IUJ Math tests are offered online on the interview days. The IUJ Math Test is conducted BEFORE the interview. Please review the eligibility to take the IUJ Math Test on page 8.

The interview serves two purposes:

1. to judge the applicant's academic and professional readiness to succeed in the IUJ programs, including career goals and research interests; and
2. to judge the applicant's English proficiency levels and cultural adaptability skills to adjust to and thrive in the diverse campus environment.

Required Application Materials

You need to submit the application items below online. Incomplete applications will not be considered. **Items in BOLD are required for all applicants.** Any discrepancies found in your documentation could result in IUJ overturning any admissions decisions either before you begin the program or thereafter.

1) ONLINE Application

Create your application ID and Password online at <https://www.iuj.ac.jp/admission/online/>. After receiving an email confirmation, return to the online site, log in and fill in all the sections in the 1st Phase (basic and required information), make the payment of the application fee, and then proceed to the 2nd Phase (supplemental information). Keep your ID and Password safe as you will need them each time you log in, and your ID to communicate with the IUJ Admissions staff.

Sections include:

1st Phase:

- ✓ **Personal Data:** Provide personal information
- ✓ **Sponsorship:** Indicate if a government or company is sponsoring you, or if you are privately funded (If you wish to apply for scholarships, choose "**Non-Sponsored.**")
- ✓ **Academic Background:** List all the educational institutions you have attended starting from the primary education, showing 16 total years of education
- ✓ **Full-time work experience:** List the organizations/companies you have worked for in a **full-time** professional capacity
- ✓ **Internship and Volunteering:** List other experience relevant to your career development
- ✓ **English Test score: TOEFL, IELTS, or TOEIC**
- ✓ GMAT/GRE or IUJ Math test score (*GSIM only*)
- ✓ **Personal Statement:** Describe your motivation and goals for attending IUJ
- ✓ **Research Topic:** Summarize the research you plan to conduct at IUJ
- ✓ **Reference:** Specify one reference such as a professor or a supervisor from your work
- ✓ **Application Fee**
- ✓ **Identification:** Upload a copy of your passport or photo data

2nd Phase:

- ✓ **Scholarship:** Optional, and for those privately funded who require financial support
- ✓ **Submit button:** Inform IUJ that you are ready for your online information to be reviewed

Please complete each section of the online application in English as fully and accurately as possible. Please respond to all questions.

2) Personal Statement

Write, independent from the assistance of others, your personal statement and upload it using the online application system. We suggest you write it offline, and after a careful review, format the document uniformly and upload it as a file such as .doc, .docx or pdf.

Word count: Between 400 and 600 words.

Please carefully note the topic of your statement as requested by the GSIR and GSIM admissions teams.

GSIR Applicants (IDP, IRP, PMPP, JGDP, IPPP):

While the choice of content is free, we suggest writing about all of the following topics:

- Motivation for coming to IUJ;
- The kind of special research you would like to conduct, and subjects you would like to focus on; and
- The reason you feel that research is important.

Please note: This statement is very important for the Admissions committee to assess your fit for the program you are applying.

GSIM Applicants (MBAs, JGDP, DXP):

Focus your statement on your Career Plans:

- Describe your short- and long-term career plans and how the IUJ program, with a significant international emphasis, will contribute to the achievement of your career goals; and
- Explain how important the international management component of the IUJ program is to the realization of those goals.

3) Research Topic

[GSIR Applicants]

In the section provided, please indicate the title and topic of your proposed IUJ Thesis. The topic should be related to your Personal Statement. Word count: Between 500 and 700 words

[GSIM Applicants]

Please download the Guidelines/Template for writing a research topic in the research topic section of the online application. Write your research topic according to the Guidelines.

4) Scanned College Certificates

- a. Transcript of academic record
- b. Certificate of graduation/degree

Through the online application system, submit scanned certificates and transcripts written in (or translated into) **English** from every undergraduate or graduate college/university you have attended. The transcripts need to include the names of all courses taken and grades received.

If you are currently enrolled in an undergraduate/graduate program and are expected to graduate by August 31, 2026, you must upload an official transcript covering courses completed by the time of application and an official letter certifying the specific date and title of the expected degree received upon completion of the program.

If you transferred to the 3rd year in an undergraduate university after completing a 2-year college program, please contact the Admissions Office about the Certificates to be submitted to IUJ.

Notes:

- Certificates/transcripts without the institution's stamp or signature of registrar will not be accepted.
- If a college/university cannot issue an official English certificate/transcript, you are required to submit both the official certificate/transcript written in its original language and its English translation prepared by a professional translator.
- Official transcripts and certificates of graduation must be submitted during the admissions procedures.

5) English Test Score: TOEFL*, IELTS or TOEIC*** Score Report**

An official TOEFL (Test of English as a Foreign Language) or IELTS (International English Language Testing System) score is required of applicants for whom the **English Test Exemption Policy** below is not applicable.

* The **TOEFL iBT Home Edition** (Online test) is also acceptable. IUJ's institution code for TOEFL score reporting is **0712**.

Note: We do not accept TOEFL-ITP scores.

** Note: IELTS includes General Training and Academic Modules in the reading and writing sections. You should take the **Academic Modules**.

*** Note: You may also submit an official TOEIC (Test of English for International Communication) score certificate. However, we strongly recommend that you take and submit your score from a TOEFL or IELTS test.

Your test score is valid as part of the application documents for admission if it was obtained **within 2 years** prior to the time of application.

Please make your test appointment early enough to allow for your scores to be reported to IUJ before our due date.

The turnaround time for these tests (i.e., how long it will take for your test scores to reach IUJ) are as follows:

TOEFL iBT: **5 weeks** (<https://www.ets.org/toefl/>).

IELTS (Academic): **4 weeks** (<https://www.ielts.org/>).

TOEIC: **4 weeks** (<https://www.ets.org/toeic/>).

Your TOEFL/IELTS/TOEIC test information must be correctly noted in the appropriate section of the online application. If you are exempted from submitting a test score (see categories below), you may indicate so in that section after carefully reading our exemption policies. If you have any questions, be sure to ask the Admissions staff.

English Test Exemption Policy

Those who fall under one of the following categories are exempted from submitting an English Test score (TOEFL, IELTS or TOEIC):

Category 1: Applicants who have received an English-medium education for at least four years during their secondary studies in **Australia, Canada, Ireland, New Zealand, the U.K. or the U.S.A.**, regardless of nationality, will be automatically exempted from submitting an English test score.

Category 2: Applicants who have completed (or are expected to complete) an undergraduate or graduate degree at an institution where the language of instruction is English may be exempted from submitting an English test score **if they submit evidence* that the medium of instruction is English** at the institution granting the degree.

* Please note that the academic transcript cannot be submitted as the evidence unless it clearly states the language of institution is English.

Those applicants who do not meet either of the above criteria must submit English test scores (TOEFL, IELTS, or TOEIC). Priority will be given in the admissions process to applicants who have at least the following scores:

TOEFL iBT: 80 (4.5 in the new scale applicable from Jan. 21, 2026)

IELTS (Academic): 6.5

TOEIC: 800

(No other English test score is accepted)

Those applicants falling below the above test scores may be required to attend the Intensive English Program during

the summer (8 weeks) prior to their first term at IUJ.

Note on IUJ English Class Exemptions

Please be aware that on-campus English exemption tests will be administered in late September for the purpose of deciding which new students need to enroll in English classes offered in regular terms. Information concerning which new students are exempted from these on-campus tests is contained in the document, 'English Exemption Policies for IR & IM Students,' which is included in the packet of documents sent to all admitted students.

Note on Japanese Language requirements: Applicants are not required to know any Japanese language because the medium of instruction at IUJ is English.

6) GMAT/GRE or IUJ Math test score (GSIM only)

A GMAT/GRE (General Test) score is required of all GSIM applicants in principle. The test score is valid as part of the application documents for admission if the score is obtained within five years prior to the time of application. Priority will be given to applicants who have higher GMAT scores (at least 550 in principle) for scholarship considerations. Please make your test appointment early enough to allow your scores to be reported to IUJ before our due date. Your GMAT/GRE result must be indicated in the appropriate section online. In addition to indicating your results online, the original test scores must be submitted online by the application deadline.

IUJ Math Test

The IUJ Math Test consists of 12 multiple-choice questions. The questions are based on the Japanese high school math curriculum, which includes matrix algebra, basic calculus (differentiation and integration), probability, and statistics. Its level is equivalent to the GMAT Quant Test. The test period is one hour, and applicants cannot use a calculator. IUJ Math Test takers must be interviewed online according to the admission schedule on pages 4-5.

Applicants eligible for the IUJ Math test are as follows:

Please note that **Group 2** in the 3rd intake is less likely to be considered for a full scholarship.

While completing your application online, you will be given the option to indicate that you would like to take the IUJ Math Test in place of submitting a GMAT/GRE test score if you are eligible to take the IUJ Math Test. Please see the table above to see if you are eligible.

For the IUJ Math Test, you will need to prepare a PC with a camera and microphone in a quiet room where you can be by yourself. The IUJ Math Test will be conducted according to the admission schedule on page 4, and the detailed schedule will be informed to applicants soon after each application deadline.

7) Reference

At the time of application, a reference letter is **NOT REQUIRED**. You are only required to provide your reference's information (name, affiliation, title, and email address*) by the application deadline. During the screening process, if the Admissions Committee sees a need for a reference letter, the Admissions Office will contact your reference and request that he or she provides such a letter. We highly suggest that you inform your reference about this process before submitting his/her name to IUJ.

Your reference should be 1) an academic advisor or professor. If 1) is not available, 2) an immediate supervisor from your workplace.

* Please provide us with a **professional email address** of your reference instead of Gmail, Hotmail, etc.

8) Application Fee

Domestic Applicants: 9,000 yen
International Applicants: 5,000 yen

All applicants are required to submit a non-refundable application fee. There are **no exceptions**.

9) Passport Copy or Photograph

If you have an international passport, submit a copy of the pages showing your full name, nationality, date of birth, photograph, passport number and expiration date. Include the pages of any and all visas relevant to Japan.

10) Residence Card Copy (Non-Japanese Domestic Applicants *only*)

Domestic applicants who are not Japanese nationals must submit a copy of their Residence Card to prove their status and address in Japan. Please be sure to upload both sides of your Residence Card as a single file with your online application.

11) Letter Attesting to Academic Research Experience (those under Category (C) in Minimum Qualifications *only*)

Those applying to IUJ under the **Minimum Qualifications for Admission Category (C)** must submit a signed letter attesting to your academic research experience written by an official at the academic institution where the research was conducted. The letter must include 1) the title or topic of your research, 2) a summary of the research, and 3) the specific time period during which the research was conducted.

Application for Scholarship

Several scholarships are available through IUJ for highly qualified non-sponsored students. IUJ selects scholarship candidates from the pool of successful applicants at the time of admissions decisions. Those requiring financial support must fill in the required online section in the 2nd phase of the online application process. Those without any financial support needs should indicate that he or she is not applying for a scholarship in that section.

For Japanese Applicants

IUJ grants S. Nakayama Memorial Scholarships to qualified Japanese applicants. To be considered for this scholarship, complete the online application form in the 2nd phase of the online system.

For Non-Japanese Applicants

IUJ grants S. Nakayama Memorial Scholarships to qualified non-Japanese applicants. All non-sponsored applicants are eligible to apply for this scholarship. IUJ also recommends qualified Non-Japanese applicants to scholarship programs provided by our affiliated organizations such as MEXT, ADB, JERA, or Mitsui. To be considered for such scholarships, complete the online application form in the 2nd phase of the online system.

Applicants are strongly encouraged to seek alternative sources of funding on their own, as not all those admitted to IUJ programs can be supported through IUJ administered financial aid.

Financial plans are especially important for international applicants, as they are a key requirement for obtaining a Certificate of Eligibility (CoE), which is necessary for a student visa. You will be required to prove to the consular officer and the Japanese Ministry of Justice that you have sufficient funds to cover expenses for study in Japan, such as the university's tuition and fees and living expenses (housing, food, clothing, etc.).

Notes:

- Recipients of any scholarships obtained through IUJ, including the S. Nakayama Memorial Scholarship, must have a Student Visa.
- The results of external scholarship selections are not available to IUJ until after mid-March or later each year. Moreover, non-Japanese applicants who are recommended by IUJ to an external scholarship foundation for consideration need to complete a separate application process (the Admissions staff will provide guidance in a timely manner) and wait for final decisions to be made regarding the granting of scholarships, which can take until the middle of July.
- Application for scholarships does not affect IUJ's consideration of a student's application for admissions.
- If you do not fill out the scholarship section of the online application, you will not be considered for any scholarships.
- Deadlines for scholarship applications are the same as admission application deadlines. A scholarship application must be submitted online along with the complete set of application materials for admission.
- There are no chances to apply for financial aid to cover tuition after entering IUJ. Students may have an opportunity to apply for some scholarships that cover only partial living expenses after enrollment, such as the JASSO Scholarship. The selection process is competitive.

Application Acknowledgment

As IUJ receives your completed online application forms, other required application materials/test scores, and supporting documentation, IUJ will send you acknowledgment messages explaining your application status, usually by email. These acknowledgement messages will contain the same unique application ID number you were given when you started your application online.

We ask you to use your Application ID number as well in all correspondence you may make with IUJ to help us identify you and provide timely support.

Admissions Results

You can confirm your admission results using your online application account on the announcement of admissions results dates listed in the table on the previous page. For successful applicants, we will send the admission package by email to each applicant. Admission decisions cannot be released by telephone, in principle.

Announced decisions are final. IUJ will not respond to any inquiries about unsuccessful results.

Admission Procedures

Successful applicants will be requested to inform us of their intention to enroll, and will be asked to submit some additional documents and pay the Admissions Fee. Only those who complete the admission procedures will be issued an official LETTER OF ADMISSIONS. This letter, along with a Certificate of Eligibility which IUJ will help you obtain, is used to apply for your Student Visa from the applicant's local Japanese embassy or consulate. Please note that a student visa will be required to receive any scholarships through IUJ. Those who fail to complete these procedures will be considered to have declined IUJ admissions. **Deferred admission is not offered at IUJ.**

Protection of Personal Information

All personal information that IUJ obtains from applicants will be used solely for the purpose of admissions screening and the student registration process in subsequent admission procedures. All application information and supporting documents provided by applicants will remain confidential, and will not be released to any third party without prior permission of the applicants.

Prospective applicants with disabilities are encouraged to contact the Admissions Office in advance.
